COMMUNICATION ON PRIVACY POLICY (under provisions of the Italian Law "Codice in Materia di Protezione dei dati Personali" D.Lgs no. 196/2007)

Dear Madam/Sir,

We wish to inform You that Legislative Decree no.196 dated 30 June 2003, Code for the protection of personal data, provides for the protection from the treatment of personal data concerning people and any other legal subjects (Companies, Associations, etc.).
